

# CRNI® Recertification 3-Year Budget Plan

## CRNI® Recertification Basics

In order to maintain your CRNI® credential, you must recertify every 3 years. You can choose to recertify in one of two ways: either by passing the CRNI® exam again or by recertifying through Continuing Education (CE).

If you are recertifying by CE, you will need a total of 40 Recertification Units (RUs), of which 30 must be obtained by attending any INS meeting (in person or online). The remaining 10 RUs may be obtained from the non-Meeting category, which includes our popular webinars, found in the INS LEARNING CENTER. Other CE options ranging from 1 to 10 RUs are listed at [www.incc1.org](http://www.incc1.org). You can earn all 40 RUs by attending the INS Annual Meeting. Don't wait until your credential is about to expire. Start planning now!

## Choose Your Recertification Pathway

### Recertification by CE

#### Option 1- The Ultimate Path

Attend an INS Annual Meeting during your 3-year certification cycle

#### Advantages

#### Investment

#### Timeline

Register for INS LEARNING CENTER activities every year during your 3-year cycle.

- Get 10 RUs (INS Meeting category) **\$195**
- 2 RUs each (webinars) **\$0 = \$195**

### Year 3

- Register for a Virtual Infusion Education activity for \$195 \*
- **Once you complete 40 RUs, submit your CRNI® recertification application with appropriate fees by the submission deadline.**
  
- Get 10 RUs (INS Meeting category) **\$195**
- Recertification application fee as an INS member **\$175**

## Recertification by Exam

INCC believes you can do anything that you set your mind to, including passing the CRNI® exam twice. You've accomplished this before, and you can do it again!

### Advantages

To recertify by exam, you must successfully pass the CRNI® exam in the final year of your certification cycle. CRNI®s choosing to recertify by exam forfeit the option to recertify by CE.
